## Working for a Better Day:

#### The Drewary Brown Story

Vinegar Hill Theater seats were packed on July 25 for a Unity Day event featuring a 2001 documentary film about Drewary Brown. The film also featured persons later honored as Bridge Builders on the Drewary Brown Bridge on West Main Street. All, like Drewary, worked across racial, economic, and other barriers to create a more just and equitable Charlottesville, and included Paul Gaston, Alicia Lugo, Grace Tinsley, and Mary Ann and Bill Elwood.

In addition to the film, four of the 36 Bridge Builders – Teresa Walker Price, Elizabeth "Betz" Gleason, Eugene Williams, and John Conover – participated in a panel discussion of the film moderated by Coy Barefoot, Executive Director, Albemarle Charlottesville Historical Society (ACHS). Kay Slaughter, editor of Bridge Builders, 2001-2016, a book of biographies, also participated.

Sponsored by Preservation Piedmont, ACHS, and Lighthouse Studios, this event was part of a larger project that Preservation Piedmont and ACHS have been engaged in since last fall when they co-sponsored a showing of the film at the Virginia Film Festival. Preservation

Piedmont helped fund the design and production of the Bridge Builder book, written by Jean Hiatt, Kay Slaughter, and Virginia Germino, and edited by Kay. A grant from Virginia Humanities supported the July 25 event and provides funds to create a Bridge Builder website. Preservation Piedmont has called on the City to make the Drewary Brown Bridge on West Main Street a more monumental site recognizing Brown and the 36 other Bridge Builders, which was also a recommendation of the 2016 Blue Ribbon Commission on Public Monuments.



# AdvocacyUpdate

### Monacan Rassawek Village >>>


#### The Center of the Monacan Millennium

"The chiefest village of Rassawek, a king's house," was reported in Captain John Smith's writings in the early 1600s. The James River Water Authority has selected this site, important to the Monacan Nation for 1000 years, as a water pump station to supply Fluvanna and Louisa. In support of the Monacans, Preservation Piedmont, along with other historic and environmental groups opposes the destruction of this village, also the site of ancestral remains. Because Rassawek has been identified for centuries, the Authority's selection prior to governmental review appears insensitive to Monacan history and culture.

Fortunately, such a project must undergo environmental and historic scrutiny under federal law. The National Environmental Policy Act (NEPA) requires that a permitting agency – in this case the U.S. Army Corps of Engineers - consider all alternatives and all environmental impacts, including historic resources, for each alternative. Moreover, Corps regulations require that it select the least damaging alternative. Currently, the Virginia Department of Historic Resources is also reviewing the proposal under the National Historic Preservation Act.

Since the Authority decided to purchase the site in advance of receiving the permit, its study is unlikely to be impartial. While there is much river frontage in Fluvanna County, the Authority purchased the Rassawek site. Assuming the Corps decides to permit the Rassawek site, the only way to negate the decision would be to challenge the permit in court.

In addition to the Monacans and other citizens who may have "legal standing" to bring a court challenge, the Governor, under federal re-

gulations is provided the authority to demand a second look. In this case, Governor Northam could object to any permit issuance for a pump station located in Rassawek, where native artifacts, including human remains, are buried. This would require the Corps to reexamine alternatives and the environmental impacts, including impacts on archeology, historic resources and human communities. No one appears to be questioning the need for the project, only the intake pump location at Rassawek; Fluvanna

County has much Rivanna waterfront within its boundaries.

The Monacan Nation has reached out to the public on this issue, and Preservation Piedmont has joined Preservation Virginia in opposition to this project. This historic site could be reserved for future generations as a natural area where the Monacans with the help of the state could conduct appropriate archeological study to help us learn more about our history.

### Other Issues We're Following >>>

#### Crozet Master Planning -

Community visioning (Phase 1) for the future of Crozet is currently underway; this will inform the design process (Phase 2) in winter & spring 2020. For more information about opportunities to engage in the conversation, please review the Community Visioning schedule.

#### Form-Based Code -

Charlottesville has been finalizing a "Form-Based Code" (FBC) for Phase 1 of the Strategic Investment Area (roughly the area from the IX complex to Friendship Court, and from Ridge St. to North Belmont) Form-based codes were developed as a way to regulate building form in areas where sprawling development has been a concern. FBC replaces conventional zoning with a

focus on the form of the buildings, streets and parks in a neighborhood. FBC sets standards for community scale and character. How well FBC functions within an existing city fabric remains to be seen, but transition zones to existing neighborhoods can be regulated through building form requirements. Preservation Piedmont will continue to monitor the impact of the proposed FBC on the City's historic and cultural resources.
